A “War Era” is a specific time frame when America is engaged in armed conflict, both domestic and abroad. This is a time when the nation's focus shifts to supporting the troops on the front lines and at home.

The currently established War Eras are:

- World War II:

December 7, 1941 – December 31, 1946

- Korean Conflict:  
June 27, 1950 – January 31, 1955
- Vietnam Era:  
February 28, 1961 – August 4, 1964 (In Vietnam or on a ship off the coast)  
August 5, 1964 – May 7, 1975 (Anywhere in the world)
- Gulf War:  
August 2, 1990 – ??? (a future date set by Presidential proclamation or law)

Based on the Gulf War entry above and the years of armed conflict post-9/11, this period of time may grow to be designated as a War Era at some point. So, proactively supporting the troops at home seems like a noble preemptive step – [Home Care Advisory Group \(HCAG\)](#) agrees.

### **Better Services for Those that Served.**

“War Era Veteran” is a designation ratified by Congress to describe a person who served in the military when the United States was actively engaged in war. However, this bleak classification does come with various benefits from the United States Department of Veterans Affairs (VA), businesses, and charitable organizations.

Educational opportunities, disability compensation and healthcare are among the programs and services that War Era Veterans are able to take advantage of. However, a veteran must have 90 days of active duty, with at least one war era day, to qualify for benefits like the VA Aid and Attendance Benefit.

Home Care Advisory Group works with VA Accredited Benefits Agents free of charge to get veterans more homecare funds through the VA Aid and Attendance Benefit. Veterans have survived unimaginable hardships and made important sacrifices for their country; they deserve respect, gratitude, and all of the assistance the government and people can muster.

*Service in a combat zone is not a prerequisite. Veterans who commenced active-duty service after September 7, 1980, are required to have served for a minimum of 24 months or the entire duration for which they were called or ordered to active duty, with at least one day served during a wartime period. Additionally, officers who began active duty after October 16, 1981, and did not previously complete a minimum of 24 months of active duty also fall under this category.*

## **More than the Numbers**

Over 16.2 million adults in the US were veterans in 2022, while about three-in-ten (29%) had combat experience at some point in their military career. Veterans make up 6.2% of the adult civilian population.

In 2020, the government spent a combined total of \$249.4 billion on supporting veterans – \$752 per person. The VA Aid and Attendance Benefit can dispense up to \$2,365 per month to veterans and their spouses for non-medical care and activities of daily life (ADLs). Sadly, only 5% of eligible veterans and living spouses take part in the benefit.

While veterans are more than numbers to be exploited, the numbers are finally starting to finally trend in their favor. In-home services are among the value-added services in the healthcare sector that are intended as a helping hand for honored heroes.
